## STATE OF OREGON COUNTY OF UMATILLA CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CARL A. JOHNSON PILOT ROCK, OR 97868

confirms the right to use the waters of EAST BIRCH CREEK and TRIBUTARIES THEREOF SPRING HOLLOW and CALIFORNIA GULCH, TRIBUTARIES of BIRCH CREEK (a tributary of the Umatilla River), for IRRIGATION of 24.64 ACRES of LAND, DOMESTIC and STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decrees are of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page 127. The dates of priority are 1883 for 6.0 ACRES, 1884 for 5.0 Acres, 1892 for 3.64 ACRES and 1900 for 10.0 acres.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.315 CUBIC FOOT PER SECOND, subject to the provisions of Paragraph 33 of said decree and all other conditions and limitations contained in said decree. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
