CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STATE OF OREGON
WATER RESOURCES DEPARTMENT

confirms the right to use the waters of LOUSE CREEK, tributary to JUMPOFF JOE CREEK, for instream use for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat and other ecological values.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Josephine County. The date of priority is JUNE 25, 1893. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.06 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion, from January 1 to December 31.

The description of the point at which flows are to be maintained is as follows:

At the location of the diversion authorized previously under Certificate 31332, located approximately at:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
35 S	6 W	WM	21	SW NE	1210 FEET NORTH 58.9 DEGREES EAST FROM THE CENTER OF SECTION 21

At the specified stream point, the amount of water to which this right is entitled shall not exceed the quantity of water legally available at the original point of diversion.

Water rights upstream of the original point of diversion shall not be subject to regulation for flows in excess of the quantities to which this instream water right is entitled at the original point of diversion.

The instream right established by this transfer shall replace a portion of instream water rights established pursuant to ORS 537.341 or 537.346 and shall be in addition to instream water rights established pursuant to ORS 537.348 or 537.470, unless otherwise specified by a subsequent order establishing a new instream water right.

The right is subject to all other terms and conditions of Certificate 31332, and any related decree.

This certificate is issued to confirm a change in use and place of use approved by an order of the Water Resources Director recorded in Special Order Volume ~~28~~, Page 112 approving Transfer T-11353, supersedes Certificate 31332, State Record of Water Right Certificates.
