## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORMAN A. AND SHIRLEY M. SEMENZA AND RICHARD CHODRICK RT 1 BOX 70-A SHERIDAN, OR 97378

confirms the right to use the waters of the SOUTH YAMHILL RIVER, a tributary to the YAMHILL RIVER for IRRIGATION of 27.0 ACRES.

This right was perfected under Permit S-20701. The date of priority is AUGUST 31, 1951. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.34 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
