 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RON LA FRANCHI

confirms the right to use the waters of THREE WELLS, tributary to CHRISTMAS LAKE for IRRIGATION of 158 ACRES, BEING 136.45 ACRES FROM WELL # 8 AND WELL # 9, AND 21.55 ACRES FROM WELL # 13.

This right was perfected under Permit G-5762. The date of priority is NOVEMBER 30, 1973. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.98 CUBIC FEET PER SECOND (CFS), BEING 1.71 CFS FROM WELL # 8 AND WELL # 9 IN ANY COMBINATION, AND 0.27 CFS FROM WELL # 13, or its equivalent in case of rotation, measured at the wells.

The points of appropriation are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of appropriation shall not exceed the quantity of water lawfully available at the original point of appropriation. The original point of appropriation is located as follows:



The water user shall maintain in-line flow meters or other suitable devices for measuring and recording the quantity of water appropriated.

This certificate is issued to confirm a change in PLACE OF USE AND POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered April 19, 2006, at Special Order Volume 68, Page 292, approving Transfer Application 10002, and supercedes Certificate 46977, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
