CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WILLOW CREEK, tributary to COLUMBIA RIVER for IRRIGATION of 22 ACRES (beginning in April of each year)

This right was confirmed by decree of the Circuit Court of the State of Oregon for Morrow County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 73. The date of priority is 1889 for 5.0 acres of irrigation and 1891 for 17.0 acres of irrigation. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.369 CUBIC FOOT PER SECOND (cfs), being 0.08 cfs as of the date 1889 and 5.0 acres and 0.29 cfs as of 1891 measured at the points of diversion.

The period of use begins in April of each year.

The points of diversion are located as follows:

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional point of diversion, together with the quantity of diverted at the old points of diversion, shall not exceed the quantity of water available from the original points of diversion.

The Director may require the water user to install a totalizing flow meter or other suitable measuring devices at each point of diversion. If the Director notifies the water user to install a totalizing flow meter or other measuring devices, the water user shall install such devices within the period stated in the notice. Once installed, the water user shall maintain the meters or measuring devices in good working order and shall allow the Watermaster access to the meters or measuring devices.


When required by the Department, the water user shall install, maintain and operate a headgate to control and regulate the quantity of water diverted. The type and plans of the headgate must be approved by the Department prior to beginning of construction and shall be installed under the general supervision of the Department.

The water user shall maintain and operate fish screening, at the new point of diversion, as required by the Oregon Department of Fish and Wildlife.

This certificate is issued to confirm a change in ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered August 31, 2009, at Special Order Volume 78, Page 803, approving Transfer Application 10617, and supersedes Certificate 52224, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
