## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOSEPH J. and SUZANNE GINET 16955 WATER GAP ROAD WILLIAMS, OR 97544

confirms the right to use the waters of THREE UNNAMED STREAMS, tributary of WILLIAMS CREEK, for IRRIGATION of 14.8 ACRES.

This right was perfected under Permit 37368. The date of priority is JULY 28, 1972. The right is limited to not more than 0.183 CUBIC FOOT PER SECOND (CFS); BEING 0.035 CFS from STREAM 1, 0.051 CFS from STREAM 2 and 0.097 CFS from STREAM 3 or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH (1/80) of one cubic foot per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 57915, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered \_\_\_\_\_\_\_, and recorded in Special Order Volume 88, Pages 842 to 843, canceling a portion of the water right. This certificate supersedes Certificate 57915.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
