CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of JOHN DAY RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION OF 8.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for GRANT COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at Page 461. The date of priority is 1878.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1/40 CUBIC FOOT PER SECOND PER ACRE IRRIGATED FROM APRIL 1 TO SEPTEMBER 30; FURTHER LIMITED TO ONE ACRE-FOOT PER ACRE PER CALENDAR MONTH TO JULY 1 AND 3/4 ACRE-FOOT PER ACRE THEREAFTER; TOTAL FIVE ACRE-FEET PER ACRE FOR SEASON, MEASURED AT POINT OF DIVERSION; IF AVAILABLE AT THE OLD POINT OF DIVERSION; BEING FRY-INGLE DITCH.

The points of diversion are located as follows:

FRY-INGLE DITCH - NW 1/4 NE 1/4, SECTION 26, TOWNSHIP 13 SOUTH, RANGE 30 EAST, W.M.; 1200 FEET SOUTH AND 1175 FEET EAST FROM THE N 1/4 CORNER OF SECTION 26; AND

PANAMA DITCH - NE 1/4 NW 1/4, SECTION 25, TOWNSHIP 13 SOUTH, RANGE 30 EAST, W.M.; 520 FEET SOUTH AND 2080 FEET EAST FROM THE NW CORNER, SECTION 25.

A description of the place of use is as follows:

NE 1/4 NE 1/4 5.0 ACRES (FRY-INGLE DITCH)  
NW 1/4 NE 1/4 3.0 ACRES (PANAMA DITCH)  
SECTION 28  
TOWNSHIP 13 SOUTH, RANGE 30 EAST, W.M.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion.

The water user shall maintain the in-line flow meter, weir, or other suitable measuring device at the Panama Ditch diversion point for measuring the water to which the user is entitled.

**NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW**


This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE FOR 5.0 ACRES AND POINT OF DIVERSION FOR 3.0 ACRES approved by an order of the Water Resources Director entered SEPTEMBER 12, 1977, and together with Certificate 44940, supersedes Certificate 25877, State Record of Water Right Certificates.

This right is subject to all other conditions and limitations contained in said decree.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
