CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of FORD CREEK, tributary to CALAPOOYA CREEK for MAINTENANCE OF SUTHERLIN RESERVOIR (a.k.a. FORD'S POND) FOR RECREATION CONSTRUCTED UNDER PERMIT R-1669.

This right was perfected under permit S-23163. The date of priority is AUGUST 19, 1954. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.55 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water used under the right perfected under permit 23163 shall be used to maintain the reservoir for recreation only. Any decline in reservoir level due to use of water for irrigation shall NOT be made up by appropriation of water under the right perfected under permit 23163. The use of water for irrigation shall be from stored water only.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning of construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in CHARACTER OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered November 22, 1993, at Special Order Volume 47, Page 376, approving Transfer Application 6695, and supersedes Certificate 23962, State record of Water Right Certificates.
