 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES W. & HELEN M. CHRISTOPHERSON

confirms the right to use the waters of LITTLE APPELEGATE RIVER, tributary to the APPELEGATE RIVER, for IRRIGATION of 3.0 ACRES AND LIVESTOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is SEPTEMBER 1, 1857. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.06 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion (POD) are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FIFTIETH of one cubic foot per second, or its equivalent for each acre irrigated. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

NOTE: This Certificate conforms to the provisions of a decree of the Circuit Court for Jackson County dated April 19, 1928, in conformity with Mandate of Supreme Court.

The quantity of water diverted at the additional point of diversion, together with that diverted at the original point of diversion, shall not exceed the quantity of water available at the original point of diversion.

The water user shall maintain and operate a fish screening and/or by-pass device, as appropriate, at the additional point of diversion consistent with the Oregon Department of Fish and Wildlife's operational and maintenance standards.

**NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW**


This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install, maintain and operate an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm an additional point of diversion approved by an order of the Water Resources Director entered June 29, 2009, at Special Order Volume 78, Page 266, approving Transfer Application 8948, and together with Certificate 85654, supersedes a portion of Certificate 81415, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
