confirms the right to use the waters of JOHN DAY RIVER, tributary to COLUMBIA RIVER for IRRIGATION, SUPPLEMENTAL IRRIGATION OF 102.5 ACRES, DOMESTIC, AND STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wheeler County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 46. The date of priority is 1905. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH cubic foot per second per acre irrigated from April 1 to September 30; further limited to one acre-foot per calendar month; total of five acre-feet per acre for season, measured at the point of diversion.

The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available at the old point of diversion under the subject right, and shall not exceed 1/40 cubic foot per second per acre irrigated to June 1 and 1/80 (ONE-EIGHTIETH) cubic foot per second per acre thereafter; further limited to one acre-foot per calendar month to June 1 and four acre-feet per acre during season April 1 to September 30, measured at the point of diversion. One-fortieth cubic foot per second per acre irrigated from April 1 to September 30; further limited to one acre-feet per acre per calendar moth; total of five acre-feet per acre for season, measured at point of diversion.

The original point of diversion, through an unnamed ditch, location described as follows:

When required by the Department, the water user shall install and maintain an in-line flow meter, a weir, or other suitable device for measuring the water to which the water user is entitled. The type and plans of the measuring device be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered April 8, 1988, at Special Order Volume 42, Page 135, approving Transfer Application 5968, and supersedes Certificate 25955, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
