CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NICK C. WEBER PO BOX 1459 MERLIN, OR 97532

confirms the right to use the waters of CREEK for DOMESTIC USE FOR 1 FAMILY, IRRIGATION OF 1.0 ACRE, AND SUPPLEMENTAL IRRIGATION OF 5.55 ACRES, and SPRING FOR SUPPLEMENTAL IRRIGATION OF 0.6 ACRE, both tributaries of GRAVE CREEK.

This right was perfected under Permit S-47310. The date of priority is JULY 15, 1982. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.09 CUBIC FOOT PER SECOND (CFS); BEING 0.005 CFS FOR DOMESTIC USE AND 0.082 CFS FOR IRRIGATION AND SUPPLEMENTAL IRRIGATION FROM CREEK, AND 0.003 CFS FOR SUPPLEMENTAL IRRIGATION FROM SPRING, or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.
