CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WATER CRESS SPRINGS IN SLAUGHTERHOUSE GULCH, tributary of JOHN DAY RIVER, for DOMESTIC USE FOR 3 FAMILIES, STOCKWATER FOR 2 BARNs, AND IRRIGATION of 2.3 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is 1868.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.09 CUBIC FOOT PER SECOND (CFS), further described below, or its equivalent in case of rotation, measured at the point of diversion.

DOMESTIC USE FOR 3 FAMILIES INCLUDING 1/2 ACRE LAWN & GARDEN EACH (TOTAL OF 1.5 ACRES) = 0.02 CFS

STOCKWATER USE WITHIN 2 BARNs = 0.01 CFS

IRRIGATION OF 2.3 ACRES = 0.06 CFS

The points of diversion are located as follows:

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may either petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in use and place of use approved by an order of the Water Resources Director entered April 28, 2003, at Special Order Volume 57, Page 477, approving Transfer Application 7420, and supercedes Certificate 25698, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
