confirms the right to use the waters of WALKER-VAN OTTEN RESERVOIR CONSTRUCTED UNDER PERMIT R-1405, tributary to SALT CREEK, for IRRIGATION of 13.31 ACRES.

This right was perfected under permit 50853. The date of priority is DECEMBER 13, 1989. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 28.0 ACRE FEET, or its equivalent in case of rotation, measured at the point of diversion.

Measurement, recording and reporting conditions:

- A. The water user shall maintain, in good working order, a totalizing flow meter or other suitable measuring device as approved by the Director at each point of diversion.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where any meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The water user shall maintain and operate fish screening as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered November 23, 2009, at Special Order Volume 79, Page 243, approving Transfer Application T-10473, and, supersedes Certificate 79992, State record of Water Right Certificates.
