confirms the right to use the waters of A SPRING STREAM, tributary to LITTLE RIVER for IRRIGATION of 0.4 ACRE.

This right was perfected under Permit S-31879. The date of priority is AUGUST 17, 1966. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.005 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall maintain a fish screen or fish by-pass device.

This certificate is issued to confirm a change in character of use, place of use, and point of diversion approved by an order of the Water Resources Director entered September 5, 2003, at Special Order Volume 58, Page 107, approving Transfer Application 7782, and supersedes Certificate 37701, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
