## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LYLE G. & GLORIA A. THOMPSON 425 COUNTRY HILL ROAD ROSEBURG OR 97470

confirms the right to use the waters of NORTH UMPQUA RIVER, tributary to UMPQUA RIVER for IRRIGATION of 1.4 ACRES.

This right was perfected under Permit S-24629. The date of priority is DECEMBER 17, 1956. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.018 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original point of diversion described as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface source as the original point of diversion.

The water user shall maintain a fish screen or fish by-pass device.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the Water Resources Director entered July 26, 1999, at Special Order Volume 53, Page 1107, approving Transfer Application 7406, and together with Certificate 76261, confirms a portion of Transfer Application 6829, entered March 7, 1995, at Special Order Volume 49, Page 109.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
