Water shall be acquired from the same surface source as the original point of diversion.

This certificate is issued to confirm a change in place of use and approved by an order of the Water Resources Director entered January 8, 1999, at Special Order Volume 53, Page 11, approving Transfer Application 6668, and supercedes Certificate 54375, State record of Water Right Certificates.
