CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL, in the SPENCER GULCH BASIN for IRRIGATION of 1.6 ACRES.

This right was perfected under Permit G-7851. The date of priority is AUGUST 18, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.02 CUBIC POOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This use may be regulated if analysis of data available discloses that the appropriation will measurably reduce the surface water flows necessary to maintain the free-flowing character of a scenic waterway in quantities necessary for recreation, fish and wildlife in effect as of the priority date of the right or as those quantities may be subsequently reduced.

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same aquifer as the original point of appropriation.

This certificate is issued to confirm a change in point of appropriation approved by an order of the Water Resources Director entered October 1, 1998, at Special Order Volume 52, Page 853, approving Transfer Application 7908, and together with Certificate 75827, supercedes Certificate 53051, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
