CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SEAWIND FARMS INC.
PO BOX 242
SIXES OR 97476

confirms the right to use the waters of BIG CREEK AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-8449, tributaries to FLORAS LAKE for TEMPERATURE CONTROL, IRRIGATION AND FLOOD HARVESTING on 0.83 ACRE.

This right was perfected under Permit S-46806. The date of priority is FEBRUARY 25, 1982. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.12 CUBIC FOOT PER SECOND (CFS), BEING 0.12 CFS FOR TEMPERATURE CONTROL, 0.02 CFS FOR IRRIGATION AND 0.04 CFS FOR FLOOD HARVESTING, PROVIDED THE TOTAL DIVERTED DOES NOT EXCEED 0.12 CFS, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water diverted for CRANBERRY OPERATIONS, together with amounts secured under any other rights existing for the same lands, is limited as follows: For temperature control, 0.15 cubic foot per second per acre. For flood harvesting or pest control, 0.05 cubic foot per second per acre. For irrigation of cranberries, ONE-FORTIETH of one cubic foot per second and 3.0 acre feet per acre for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop, ONE-EIGHTIETH of one cubic foot per second and 2.5 acre feet per acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This certificate is issued to confirm a change in place of use approved by an order of the Water Resources Director entered April 13, 1998, at Special Order Volume 52, Page 372, approving Transfer Application 7215, and together with Certificate 75573, supercedes Certificate 67225, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
