CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DANIEL Q. SOMERS PO BOX 1335 CAVE JUNCTION OR 97523

confirms the right to use the waters of SUCKER CREEK, tributary to EAST FORK ILLINOIS RIVER for IRRIGATION OF 5.2 ACRES, DOMESTIC, AND STOCK FOR TRACT #1, and IRRIGATION OF 1.45 ACRES FOR TRACT #4.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JOSEPHINE County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volumes 1 and 5, at Pages 252 and 397. The date of priority is 1857 FOR TRACT #1 AND 1908 FOR TRACT #4.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.121 CUBIC FOOT PER SECOND (CFS), FURTHER LIMITED TO 0.104 CFS FOR TRACT #1 AND 0.017 CFS FOR TRACT #4, or its equivalent in case of rotation, measured at the point of diversion, and that the use of said water for IRRIGATION purposes shall be confined to the irrigation season APRIL 1 TO OCTOBER 31 OF EACH YEAR.

The point of diversion is located as follows:

This certificate is issued to confirm a CHANGE IN POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered APRIL 18, 2003, at Special Order Volume 57, Page 456, approving Transfer Application 8918, and together with Certificate 79996, supercedes a portion of Certificate 7139, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
