confirms the right to use the waters of BEAR CREEK, tributary to COAST FORK WILLAMETTE RIVER for POND MAINTENANCE.

This right was perfected under Permit 35896. The date of priority is FEBRUARY 2, 1971. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.013 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The quantity of water for pond maintenance shall be limited to a rate of diversion not to exceed 0.013 cubic foot per second and shall be further limited to a total quantity not to exceed 2.5 acre feet during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
