confirms the right to use the waters of EAST FORK EVANS CREEK, tributary to EVANS CREEK AND SUPPLEMENTAL SUPPLY FROM SPIGNET CREEK, TRIBUTARY TO EAST FORK EVANS CREEK for IRRIGATION of 0.26 ACRE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1892 FOR EAST FORK EVANS CREEK AND 1871 FOR SPIGNET CREEK.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.005 CUBIC FOOT PER SECOND FROM BOTH SOURCES, SUBJECT TO THE PROVISIONS OF PARAGRAPH 79 OF SAID DECREE, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

A description of the place of use is as follows:

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water user shall maintain a fish screen or fish by-pass device, as appropriate, at the point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
