CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BRUCE R AND VELAN E CHAPIN

confirms the right to use the waters of CLEAR LAKE, tributary to WILLAMETTE RIVER for IRRIGATION of 14.5 ACRES.

This right was perfected under Permit S-24025. The date of priority is JANUARY 19, 1956. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.18 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion (well) is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
6 S	3 W	WM	23	NW NW	2 FEET SOUTH AND 657 FEET EAST FROM NW CORNER, SWNW, SECTION 23

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point(s) of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original point of diversion described as follows:

6 S	3 W	WM	23	SW NW

Water shall be acquired from the same surface source as the original point of diversion.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW



A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a CHANGE IN POINT OF DIVERSION approved by an order of the Water Resources Director entered MAY 24, 2000, at Special Order Volume 54, Page 416, approving Transfer Application 7458, and supercedes Certificate 23735, State record of Water Right Certificates.
