CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TWO SUMP WELLS WITH NAY DEFICIENCY IN THE AVAILABLE SUPPLY FROM SUMP NO. 1 TO BE MADE UP BY APPROPRIATION FROM SUMP NO. 2 PROVIDED THAT THE TOTAL QUANTITY DIVERTED FROM BOTH SOURCES SHALL NOT EXCEED 0.60 CUBIC FOOT PER SECOND, within the to CROFT LAKE BASIN, for IRRIGATION, TEMPERATURE CONTROL, AND HARVESTING CRANBERRY ON 7.5 ACRES.

This right was perfected under Permit G-4773. The date of priority is DECEMBER 26, 1969. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.60 CUBIC FOOT PER SECOND (CFS), BEING 0.19 CFS FOR IRRIGATION, 0.60 CFS FOR TEMPERATURE CONTROL AND 0.38 CFS FOR HARVESTING FROM SUMP NO. 1, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to a diversion not to exceed 2.5 acre feet per acre per year for each acre irrigated during the irrigated and shall be further limited to a diversion not to exceed 2.5 acre feet per acre per year for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
