CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of FIFTEEN MILE CREEK, a tributary of the COLUMBIA RIVER for IRRIGATION of 9.8 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for WASCO County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7, at Page 406. The date of priority is 1870.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3 ACRE FEET IN ANY IRRIGATION SEASON, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install and maintain a headgate, in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface source as the original point of diversion.

This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the Water Resources Director entered November 14, 1997, at Special Order Volume 51, Page 1284, approving Transfer Application 6720, and supercedes Certificate 5628, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.
