confirms the right to use the waters of A WELL, within the PATAWA CREEK BASIN for IRRIGATION of 6.33 ACRES.

This right was perfected under Permit G-9321. The date of priority is FEBRUARY 11, 1980. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.063 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation described as follows:

The water user shall maintain an in-line flow meter, or other suitable device for measuring and recording the quantity of water diverted.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
