CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RONALD R. REESER BOX 838 PILOT ROCK, OR 97868

confirms the right to use the waters of TWO WELLS in the BIRCH CREEK BASIN for IRRIGATION of 935.3 ACRES.

This right was perfected under Permit G-6361. The date of priority is SEPTEMBER 8, 1975. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 10.546 CUBIC FEET PER SECOND being 5.496 cfs from Well No. 1 and 5.05 cfs from Well No. 2 or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year provided further that in the event that use of the wells under this right unduly interfere with or cause excessive water level declines in wells of earlier priority in the area, it may become necessary to materially reduce or terminate ground withdrawals from the wells under this permit. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
