CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MT. HOOD IRRIGATION DISTRICT
P.O. BOX 426
MT. HOOD, OREGON 97041

confirms the right to use the waters of EAST FORK HOOD RIVER, a tributary of HOOD RIVER, for IRRIGATION of 851.82 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Hood River County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 17, at Page 333. The date of priority is NOVEMBER 27, 1895.

The use is limited to 10.65 CUBIC FOOT PER SECOND (CFS), IF AVAILABLE at the original point of diversion at the following location:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH (1/80) of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Hood Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate together with certificate 88167 supersedes certificate 64423.
