CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MT. HOOD IRRIGATION DISTRICT
P.O. BOX 426
PARKDALE, OREGON 97041

confirms the right to use the waters of EAST FORK HOOD RIVER, a tributary of HOOD RIVER, for IRRIGATION of 72.38 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Hood River County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 17, at Page 333. The date of priority is NOVEMBER 27, 1895.

The use is limited to 0.90 CUBIC FOOT PER SECOND (CFS), IF AVAILABLE at the original point of diversion at the following location:

Or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH (1/80) of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This certificate describes that portion of the water right confirmed by certificate 64423 State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on April 25th, 2013, and recorded in Special Order Volume 89, pages 414 to 429, approving a petition by Mt. Hood Irrigation District under ORS 541.329. This certificate together with certificate 88166 supersedes certificate 64423.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
