## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KYLE GRAY 4230 AUBERT DRIVE PARKDALE, OR 97041

confirms the right to use the waters of an UNNAMED SPRING-STREAM and RESERVOIR constructed under Permit R-3425, a tributary of EAST FORK HOOD RIVER, for IRRIGATION (IR) of 3.70 ACRES and SUPPLEMENTAL IRRIGATION (IS) of 27.3 ACRES.

This right was perfected under Permit S-28983. The date of priority is SEPTEMBER 9, 1963.

The amount of water to which this right is entitled is limited to an amount actually beneficially used for the described purposes and shall not exceed 0.05 CUBIC FOOT PER SECOND (CFS) and 4.75 ACRE-FEET of STORED WATER ONLY.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH (1/80) of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.0 ACRE-FEET per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-3425, and further limited to the use of stored water only for supplemental irrigation on the lands described.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
