CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of BALDWIN CREEK, a tributary of EAST FORK HOOD RIVER, for SUPPLEMENTAL IRRIGATION of 0.90 ACRE.

This right was perfected under Permit 38355. The date of priority is JULY 2, 1973. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.01 CUBIC FOOT PER SECOND (CFS), or the equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH (1/80) of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate describes that portion of the water right confirmed by Certificate 55995, State Record of Water Right Certificates, diminished from irrigation to supplemental irrigation by the provisions of an order of the Water Resources Director entered on April 25<sup>th</sup>, 2013, and recorded in Special Order Volume 89, Pages 414 to 429, approving a petition by Mt. Hood Irrigation District under ORS 541.329 for mapping water rights within a district.

This certificate supersedes water right certificate 55995 in the name of Danny Green and Tim Chambers.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
