CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THE VINTAGE GROUP LLC

confirms the right to use the waters of LITTLE WALLA WALLA RIVER, tributary to WALLA WALLA RIVER for IRRIGATION of 4.28 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at Page 9. The date of priority is 1880.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE AND ONE-HALF MINER'S INCHES PER ACRE or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

A description of the place of use is as follows:

The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.

The water user shall maintain the existing headgate and shall make such improvements as may be required by the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.



NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered OCTOBER 5, 2009, at Special Order Volume 79, Page 14, approving Transfer Application 10430, and together with Certificate 85854, supercedes Certificate 13240, State Record of Water Right Certificates.
