CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARY ELLEN BROOKS

confirms the right to use the waters of the JOHN DAY RIVER and BEACH CREEK, tributaries to the COLUMBIA RIVER for IRRIGATION of 4.5 ACRES.

This right was perfected under Permit E-134. The date of priority is APRIL 1, 1912. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.058 CUBIC FOOT PER SECOND, if available at the authorized point of diversion or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the additional points of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available from the original point of diversion.

The water available from the original point of diversion described as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.


Water shall be acquired from the same surface source as the original point of diversion.

The water user shall maintain a fish screen and/or fish by-pass device.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change ordering approving an additional point of diversion approved by an order of the Water Resources Director entered July 31, 2001, at Special Order Volume 55, Page 818, approving Transfer Application 8475, and together with Certificate 77014, supercedes Certificate 52024, State record of Water Right Certificates.
