## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ARNOLD AND EDITH L CONZELMANN 11964 SE 175<sup>TH</sup> AVE BEAVERTON OR 97007

confirms the right to use the waters of AN UNNAMED DRAINAGE WAY AND RESERVOIR CONSTRUCTED UNDER APPLICATION R-43747, PERMIT R-5025, a tributary to CHICKEN CREEK for IRRIGATION of 8.0 ACRES.

This right was perfected under Permit 32692. The date of priority is JUNE 22, 1968. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.10 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-5025.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
