CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WALLA WALLA RIVER IRRIGATION DISTRICT PO BOX 248 MILTON FREEWATER OR 97862-0248

confirms the right to use the waters of FORD BRANCH AND EAST CROCKETT BRANCH OF LITTLE WALLA WALLA RIVER, tributary to WEST LITTLE WALLA WALLA RIVER for IRRIGATION of 4.25 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at Page 9. The date of priority is DECEMBER 31, 1890.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE AND ONE-HALF MINERS INCHES PER ACRE, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The water user or irrigation district shall install and maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user or irrigation district shall operate and maintain the headgates and measuring devices, as needed. The water user or irrigation district shall report total flow figures when requested by the Watermaster. The Watermaster may operate the headgate and monitor accuracy of the measuring device, as needed.

The water user or irrigation district shall notify the Watermaster which point of diversion will serve which lands. The water user or irrigation district shall notify the Watermaster prior to using the alternate point of diversion for these lands.

Water shall be acquired from the same surface source as the original point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 2, 1998, at Special Order Volume 52, Page 923, approving Transfer Application 7760, supercedes Certificate 12900, State Record of Water Right Certificates.
