CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of LOST CREEK RESERVOIR, tributary to ROGUE RIVER for SUPPLEMENTAL IRRIGATION of 11.0 ACRES.

This right was perfected under Permit 50173. The date of priority is AUGUST 12, 1987. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 11.0 ACRE FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 4.5 acre-feet (or its equivalent) for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein. This right is also subject to the terms and conditions of Contract 7-07-10-W0691 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Department.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 6, 1996, at Special Order Volume 50, Page 792, approving Transfer Application 7555, and together with Certificate 73400, supersedes Certificate 64958 State record of Water Right Certificates.
