CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of EAST FORK DAIRY CREEK, tributary to DAIRY CREEK for NURSERY USE of 4.0 ACRES DURING THE PERIOD OCTOBER 1 TO APRIL 30.

This right was perfected under Permit 47121. The date of priority is NOVEMBER 12, 1981, for 0.01 CUBIC FOOT PER SECOND AND OCTOBER 25, 1982 for 0.04 CUBIC FOOT PER SECOND. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.05 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
