CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARSHA J HORSELY 17911 N APPLEGATE RD GRANTS PASS OR 97527

confirms the right to use the waters of APPLEGATE RIVER, tributary to ROGUE RIVER for IRRIGATION of 8.63 ACRES.

This right was perfected under Permit 3031. The date of priority is JULY 21, 1916. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.11 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion (POD) are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original point of diversion.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the

petition shall be deemed denied.

Water shall be acquired from the same aquifer as the original point of appropriation.

The water user shall maintain a fish screen or fish by-pass device.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered AUGUST 16, 2000, at Special Order Volume 54, Page 580, approving Transfer Application 8357, and supercedes Certificate 48359, State record of Water Right Certificates.
