CERTIFICATE OF WATER RIGHT

OK CORRAL ROBERT HAMLYN 966 SW 6TH ST GRANTS PASS OR 97526

confirms the right to use the waters of ROGUE RIVER, a tributary of PACIFIC OCEAN for IRRIGATION of 3.8 ACRES.

This right was perfected under Permit S-11644. The date of priority is APRIL 12, 1935. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.05 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion (well) is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

This certificate is issued to confirm a CHANGE IN POINT OF DIVERSION TO POINT OF APPROPRIATION approved by an order of the Water Resources Director entered JUNE 7, 2004, at Special Order Volume 60, Page 200, approving Transfer Application 9482, and together with Certificate 80760, supersedes Certificate 12026, State record of Water Right Certificates.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
