## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A SUMP WELL, within the WILLIAMS CREEK BASIN for IRRIGATION OF 1.0 ACRE AND SUPPLEMENTAL IRRIGATION OF 3.5 ACRES.

This right was perfected under Permit G-4486. The date of priority is JANUARY 15, 1969. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.06 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered NOVEMBER 21, 2005, at Special Order Volume 67, Page 458, approving Transfer Application 8682, and together with Certificate 81702, supercedes Certificate 42080, State record of Water Right Certificates.
