CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROGER AND MARY BAKKE
2303 78TH AVE SE
SALEM OR 97317

confirms the right to use the waters of A WELL, within the LITTLE PUDDING RIVER BASIN for SUPPLEMENTAL IRRIGATION of 29.8 ACRES.

This right was perfected under Permit G-3236. The date of priority is MAY 5, 1966. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.37 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The water user shall maintain a meter or other measuring device suitable to the Director, and shall submit an annual report of water used to the Department by December 1 of each year.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.


The water user shall be responsible for complying with each of the following requirements for measuring water levels in the well.

- a) A water level measurement shall be made each year during the period March 1 through March 31.
- b) All water level measurements shall be made by a qualified individual. Qualified individuals are certified water rights examiners, registered geologists, registered professional engineers, licensed land surveyors, licensed water well constructor, licensed pump installer, or the appropriator.
- c) Any qualified individual measuring a well shall use standard methods of procedure and equipment designed for the purpose of well measurement. A list of standard methods of procedure and suitable equipment shall be available from the Department.
- d) The well shall be equipped with an access port and dedicated measuring tube that comply with standards set forth in OAR 690-215-0060.
- e) The appropriator shall submit a record of the measurement to the Department on a form available from the Department. The record of measurement shall include both measurements and calculations, shall include a certification as to their accuracy signed by the individual making the measurements, and shall be submitted to the Department within 90 days form the date of measurement

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered MAY 13, 2009, at Special Order Volume 77, Page 736, approving Transfer Application 10675, and an order of the Water Resources Director entered JUNE 15, 2009, at Special Order Volume 78, Page 124, superseding Special Order Volume 77, Page 736, and supercedes Certificate 82188, State record of Water Right Certificates.
