## **CERTIFICATE OF WATER RIGHT**

THIS CERTIFICATE ISSUED TO

JOSEPH L SONKA 901 NW CHADWICK LANE MYRTLE CREEK OR 97457

confirms the right to use the waters of SOUTH UMPQUA RIVER, a tributary of the UMPQUA RIVER, for IRRIGATION of 27.5 ACRES.

This right was perfected under Permit S-12200. The date of priority is JUNE 1, 1936. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.34 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The quantity of water diverted at the new point of diversion, together with that diverted at the old points of diversion, shall

not exceed the quantity of water lawfully available at the original points of diversion as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface water source as the original points of diversion.

The water user shall maintain a fish screen or by-pass device.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered November 5, 1998, at Special Order Volume 52, Page 960, approving Transfer Application 6059 and together with Certificate 75845, supersedes Certificate 45744, State record of Water Right Certificates.
