confirms the right to use the waters of SOUTH FORK WALA WALLA RIVER, tributary to COLUMBIA RIVER for IRRIGATION of 3.58 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at Page 9. The date of priority is 1881.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE-HALF MINERS INCHES per acre, or its equivalent in case of rotation, measured at the point of diversion.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water available from the original point of diversion described as Dorothy Ditch.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water user shall report total flow figures when requested by the Watermaster. The Watermaster may operate and monitor the accuracy of the measuring device, as needed.

Water shall be acquired from the same surface source as the original point of diversion.

The water user shall maintain a fish screen or fish by-pass device.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
