## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LARSON LAND CO., LLC dba LARSON SKYLINE FARMS PARTNERSHIP 4395 HEINZ BLVD. ONTARIO, OR 97914

confirms the right to use the waters of the SNAKE RIVER, a tributary to the COLUMBIA RIVER for SUPPLEMENTAL IRRIGATION of 159.0 ACRES.

This right was perfected under Permit S-33945. The date of priority is OCTOBER 25, 1968. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.129 CUBIC FEET PER SECOND (cfs), or its equivalent in case of rotations, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 1/40 of one cfs, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the land or place of use described.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to correct the rate and duty under Certificate 84864, and confirms a reduction in rate of diversion approved by an order of the Water Resources Director recorded in Special Order Volume 76, Page 435, approving conserved water application CW-55, and together with Certificate 84697 (the remaining right) supersedes Certificate 74022.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
