## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of LITTLE CREEK, tributary to CATHERINE CREEK for IRRIGATION of 17.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 8, at Page 1. The date of priority is 1866.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed THREE ACRE FEET PER ACRE in any irrigation season at a rate not to exceed ONE-FORTIETH OF A CUBIC FOOT PER SECOND per acre.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

B. The water user shall allow the watermaster access to the measuring device; provided however, where the measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered SEPTEMBER 8, 2010, at Special Order Volume 81, Page 831, approving Transfer Application 10870, and supersedes Certificate 84366, State Record of Water Right Certificates.
