## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SOUTH MYRTLE CREEK, tributary to MYRTLE CREEK for IRRIGATION of 40.0 ACRES.

This right was perfected under Permit S-8310. The date of priority is APRIL 5, 1927. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.5 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion (POD) are located as follows:
