CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

APPLEGATE INVESTMENTS INC. HUNTER, BILLY JOE 7170 HWY 238 JACKSONVILLE OR 97530

confirms the right to use the waters of FOREST CREEK AND HUNTER AND BEST RESERVOIRS NOS. 1 AND 2 CONSTRUCTED UNDER PERMIT R-2370, tributaries to APPLEGATE RIVER for IRRIGATION OF 21.9 ACRES AND SUPPLEMENTAL IRRIGATION OF 6.1 ACRES.

This right was perfected under Permit 26859. The date of priority is JULY 5, 1960. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.355 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoirs constructed under Permit R-2370; provided further that the right to the use of direct flow is limited to the period when the flow of the Rogue River is more than 735 cufic feet per second at its mouth. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
