CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LAVERNE M AUSTIN JOYCE F AUSTIN 2136 NE TODD GEORGE RD LEES SUMMIT MO 64086

confirms the right to use the waters of SNAKE RIVER, tributary to COLUMBIA RIVER for IRRIGATION of 41.0 ACRES.

This right was perfected under Permit S-1150. The date of priority is FEBRUARY 17, 1912. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.49 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The water user shall operate and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The water user shall report total flow figures when requested by the Watermaster. The Watermaster may operate the headgate and monitor the accuracy of the measuring device, as needed.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
