## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of POWDER RIVER, tributary to SNAKE RIVER for IRRIGATION of 4.2 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 6, at Page 291. The date of priority is DECEMBER 1, 1899.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE-FORTIETH OF ONE CUBIC FOOT PER SECOND PER ACRE (0.11 CUBIC FOOT PER SECOND), or its equivalent in case of rotation, measured at the point of diversion.

This certificate is issued to confirm a CHANGE IN POINT OF DIVERSION approved by an order of the Water Resources Director entered AUGUST 9, 2004, at Special Order Volume 61, Page 52, approving Transfer Application 9589, and together with Certificate 80774, supercedes Certificate 4391, State Record of Water Right Certificates.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
