CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of NORTH UMPQUA RIVER, tributary to UMPQUA RIVER for IRRIGATION of 0.3 ACRE.

This right was perfected under Permit S-19661. The date of priority is MAY 10, 1950. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.004 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHT1ETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, subject to the terms and conditions of that agreement between Elton V. Jackson and the California Oregon Power Company dated September 1, 1950.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The water user shall maintain and operate the fish screen and/or fish by-pass device, as appropriate, at the point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

The Director may require the water user to install a totalizing flow meter or other suitable measuring devices at the point of diversion. If the Director notified the water user to install totalizing flow meters or other measuring devices, the water user shall install such devices specified by the Director within the period allowed in the notice. Once installed, the water user shall maintain the meters or measuring devices in good working order and shall allow the Watermaster access to the meters or measuring devices.

This certificate is issued to confirm a CHANGE IN POINT OF DIVERSION approved by an order of the Water Resources Director entered DECEMBER 30, 2009, at Special Order Volume 79, Page 1292, approving Transfer Application 10685, and together with Certificate 86120, supercedes Certificate 83265, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
