CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to store the waters of UNNAMED STREAM IN BOWLES POND, tributary to SPRING VALLEY CREEK for IRRIGATION.

This right was perfected under Permit R-5133. The date of priority is JUNE 27, 1968. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.2 ACRE FEET DURING THE PERIOD FROM SEPTEMBER 1 TO JUNE 30 OF EACH YEAR, or its equivalent in case of rotation, measured at the point of diversion.

All natural flow in excess of 2.2 acre-feet must be passed through the reservoir.

The point of diversion and dam location is as follows:

The area submerged by this reservoir is as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in CHARACTER OF USE approved by an order of the Water Resources Director entered NOVEMBER 27, 1998, at Special Order Volume 52, Page 1038, approving Transfer Application 7273, and supersedes Certificate 37031, State record of Water Right Certificates.
